Benefits and refundable tax credits help with your living expenses by adding to your income. Whether you qualify and how much you receive depends on your income which is determined by filing your taxes and on other factors such as your age. The Government of Canada website has a **Benefit Finder tool** that you can use to help you find the benefits and services that you can receive. Benefits and credits accessed by tax filing

Even if you have no income or do not owe taxes, it is important to keep up to date with filing your taxes. Filing a tax return is the only way to apply to many benefits and credits or to make sure that your payments continue. Here are some of the benefits and refundable tax credits that require tax filing to access or to continue receiving payment:

Each province and territory offer programs that provide financial help to people living on a low income. Social assistance programs give people money to help pay for living expenses like food, clothing, and shelter, and in some cases prescription drugs and dental services. Each program has their own eligibility criteria and restrictions. In general, you must live in the province or territory and be in financial need.
